### **RE: Milford Water Company Valuation, D.P.U. 18-60**

Dear Secretary Marini:

On behalf of the Town of Milford ("Town"), enclosed are an original and two copies of the pre-filed Direct Testimonies and exhibits of John J. Reed, Richard Fedder, and James J. Rivard.

This matter is before the Department of Public Utilities ("Department") upon referral by the Supreme Judicial Court of *In re Milford Water Company*, No. SJ-2018-0029, "to determine, as required by St. 1881, c. 77, § 9, and G.L. c. 165, § 5, the amount of compensation to be paid by the town for its planned purchase of 'the corporate property and all rights and privileges' of the Milford Water Company." The Town sponsors the pre-filed testimony of James J. Rivard to provide a condition assessment and reproduction cost new analysis of the Milford Water Company ("MWC") water system assets, and based on these findings, the pre-filed testimony of Richard Fedder provides a reproduction cost new less depreciation analysis. The Town sponsors the testimony of John J. Reed (1) to provide an analysis of the appropriate valuation method to apply to determine the compensation to be paid for the Company's assets, and (2) to determine the compensation to be paid.
